What does asylum in Germany mean?

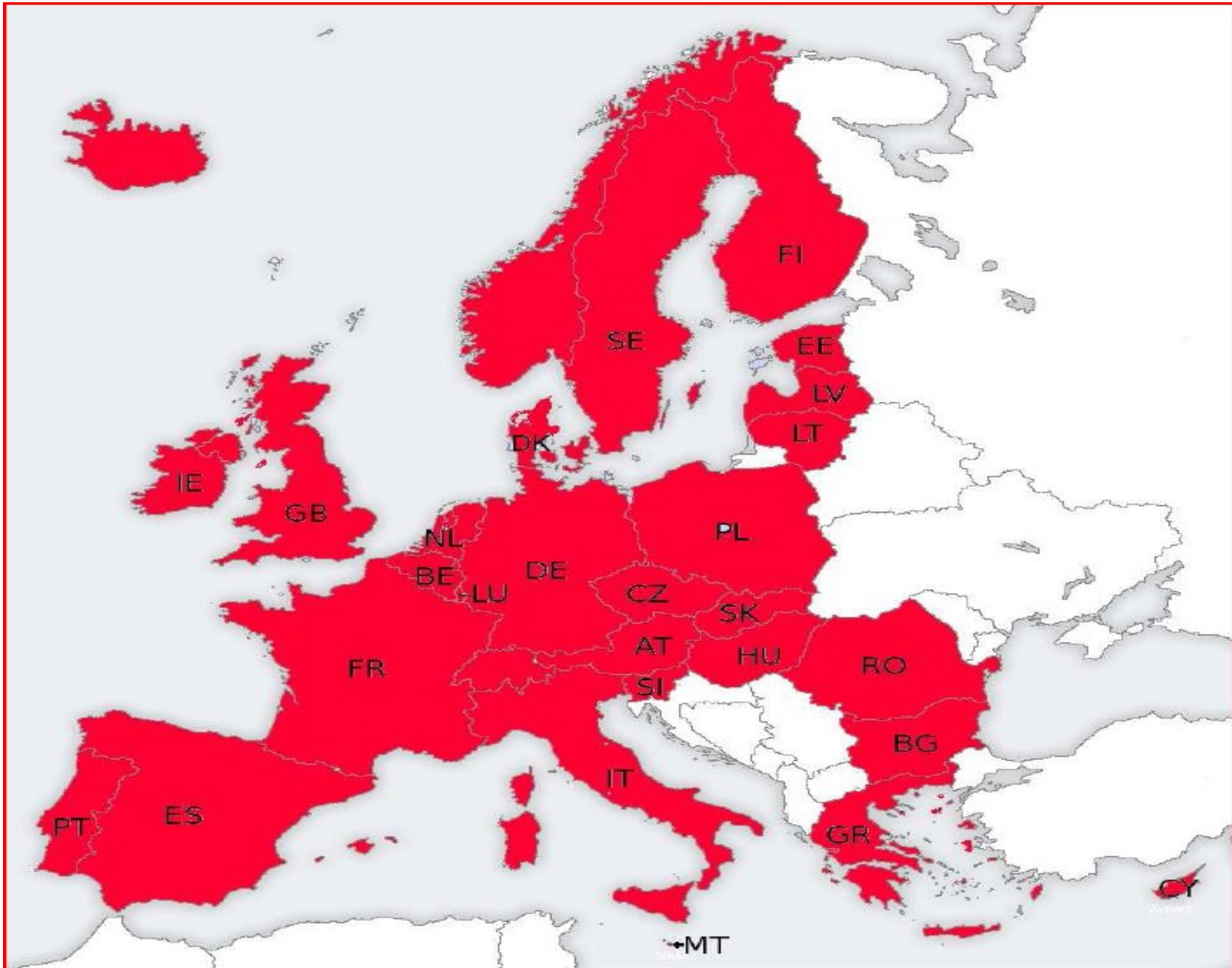
- general right on asylum for people who suffer from political persecution (so called „economic reasons“ are excluded)
- Since 1992/1993 restriction on fundamental right on asylum. Principle of „safe country of origin“ (at this time Senegal / Ghana), Asylbewerberleistungsgesetz
- Several new restrictions in 2015
- Opportunity of humanitarian protection (for example because of medical reasons)

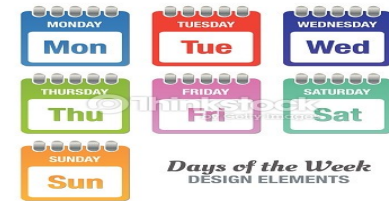

Legal steps against Dublin procedure need to be very fast (1 week).



You need to explain problems you had in the other european country.

In most of the cases medical papers are necessary to get protection

→ It is very important to prepare for a Dublin procedure even before you receive the yellow letter.



Note: all of this countries are considered „safe countries of origin“ by now

For people from some countries it is very difficult to be accepted as a asylum seeker

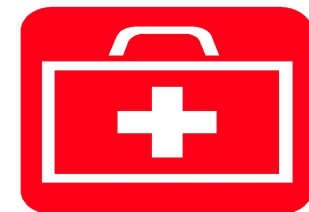
There are some rights and opportunities anyway

It is also possible to get humanitarian protection (for example because of medical reasons)

- The „big“ hearing is very important for the asylum procedure and needs good preparation
- You need to make sure if you are in danger of deportation or not



- If you are not able of travelling because of medical reasons this can give you some protection from deportation



Hearing

- **Preparation**

reasons for leaving the country → political persecution
medical/psychological situation

- **Translation**

reliable/trustworthy interpreter
retranslation of protocol

- **You got the right to speak**

support of friend or lawyer

be aware of trick questions (→ no economic reasons)

People from some countries got a very good chance to get a positive decision

There is no Dublin procedure for people from Syria at the moment

Note: dublin procedure has been started again for people from Syria now

Steps:

- 1. Registration/“small interview“ → green „Aufenthaltsgestattung“
- 2. hearing/written „big“ interview
- 3. Recognition as a asylum seeker → 3 years paper (Aufenthaltsgenehmigung)
- 4. Chance to bring husband/wife and kids also to Germany leagally

There is almost no legal chance to make things happen faster except preparing for step 4. in advance if necessary. In some cases a „Untätigkeitsklage“ can be an option
